5. That the objects for which this Trust is established are:

- 1) To arrange an attendant, nurse for the care of patients, old people etc. in the hospital and their residence.
- 2) According to their needs of medical devices, arrangements for sick patients such as: Hospital beds, Wheel chair, Oxygen, C-Pap, Ventilator, Suction machine, Cardiac monitor etc.
- 3) To arrange ambulance services.
- 4) To arrange physical therapists for physiotherapy services.
- 5) Organizing natural physicians for Naturopathy services.
- 6) Arranging vehicles for dead body as needed.
- 7) Distribution to the needy, ashram, ashram, and food, blankets, shawls, shoes, umbrellas etc. to the needy and dependable person.
- 8) Provide assistance for free medicines and medical equipment and start the program.

6. PATRONS

7. TRUSTEES or MEMBERS

7.1 All persons who have attained 21 years of age and have subscribed to the aims and objects of the Trust subject to the approval of the Governing Body will be entitled to be its Trustees. The decision of the Governing body in this regard shall be final and binding.

7.2 The Trustees will not be entitled to receive any profit, but the Trustees may receive honorarium and reimburse all expenses actually incurred by them in connection with their duties relating to Trust.

7.3 The Trustees shall be accountable only for such moneys, and funds, which will actually come into their hands.

- 7.4 In order to become a member of our organization, membership will be given as a fee of 1,000 donations.
- 7.5 Members of our organization can make co-members.
- 7.6 The member of our organization should not be bankrupt.
- 7.7 All members and co-members of our institution will have to pay membership fee in the form of donations
- 7.8 Our institution can provide reward and honorarium to the member.
- 7.9 There is no limited number of members of our organization
- 7.10 The member of our organization can also become a member by filling out the online application form.

Types of Members / Types / Categories: The institution will consist of four different categories:

- i. **Founder Member-** A member who has been accepted as a founding member at the time of registration of the institution and has got the founder membership fee in the institution. The number of founding members will not exceed 2. Founding members will also be considered and seen to be formed.

- iv. **Honorable Members -** Board of Directors can accept honorable members of prestigious talent and qualifications, or are considered hardworking and employed for the organization. Those who are ready to provide excellent

10. MANAGING TRUSTEE

Mr. Pranav Bajpai shall be designated as the Managing Trustee of the trust. He will be at liberty for the time being to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.

11. MEETINGS

11.1 The governing body will be held, at least, once in four months, notice of such meeting being given, at least, 15 days in advance. Decision will be taken as far as possible by consensus and in the event of any difference by majority where the votes are equal, the President will have the casting vote.

11.2 The meeting of the Governing body shall be held at such time and place as the President may decide from time to time and all the meeting of the Governing Body shall be presided over by the President and in his absence by any one of the trustees. The annual general meeting shall be held not latter than six months after the closing of the financial year.

12. ACCOUNTS

12.1 Audit of Accounts:

A Chartered Accountant shall audit the accounts of the trust/society every year.

12.2 Operation of Bank Account:

The governing Body have power to open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.

12.3 Settlement of Account:

The Governing Body will settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

- 18.3 That the Trustees shall always maintain proper books of accounts which shall be kept at the office of the trust.
- 18.4 In the matter of investment of Trust funds, the provision of section 20 of the Indian Trust Act 1882 shall apply.
- 18.5 The organization provides services and service to the physically handicapped and old age of the patient and the patient and at the patient's home and in the institution. And all the income received from the service is the amount of donation.
- 18.6 The institution also provides emergency ambulance facility. And the amount received from him is a donation.

- 18.11 To fulfill the objectives and goals of the institution and to purchase fixed assets like land house machines, furniture, cars, computers, health care machines, ambulance vans, and other types of property, the amount of loans and loans taken From time to time, any finance company and government and non-government bank will return the loan.

- 19.3 To administer and control the affairs and funds of the Trust and exercise all power of the Trust in order to carry out the aims and objects of the Trust and manage all the institutions established by the Trust.
- 19.4 To purchase take on lease or in exchange or hire or otherwise acquire any movable or immovable property for the purpose of the Trust and to carry out agreement, loan, grants and other assistance in suitable terms.
- 19.5 To provide grant in-aid and other financial assistance to voluntary organization and work as link between NGO's working in different parts of India and donor agencies and individual donors.
- 19.6 To accept any donation, contribution, grant-in-aid, subscription in cash or in kind from any person, body of persons, trust, foundations, Govt. Departments or Funding agencies with or without conditions.
- 19.7 To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto to, any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- 19.8 To borrow or raise or secure payments of moneys and also to lend money either with or without security, alienate or otherwise deal with any property comprising the trust fund.
- 19.9 To let out, dispose of any immovable property comprised in the Trust Fund for such period and such rent on such terms and conditions as the Trustees in their discretion may think fit.
- 19.10 To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.

- 19.11 To take over, acquire, manage, control or amalgamate with any Institution having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- 19.12 To join, co-operate or amalgamate this trust with other or others having allied objects upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- 19.13 To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- 19.14 To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise to different charitable institutions, societies organizations or Trusts in India which may have been established or which may hereinafter be established for the like charitable purposes.
- 19.15 To grant loan to institutions or persons either on interest or without interest on such terms and conditions as trustees may in their absolute discretion think fit and set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund.
- 19.16 To apply for grant-in-aid or donation to the Government Departments and Funding Agencies and to accept grants, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- 19.17 The Governing body shall meet as often as necessary but at least once in every calendar quarter at such place and time as the Managing Trustee may decide. He will send the notice and agenda of these meetings to all members of the Governing Body at least fifteen days before the date fixed for the meeting. The quorum for the meeting shall be one third subject to minimum two trustees.
- 19.18 Whenever the Managing Trustee is of the opinion that a special meeting of the Governing Body is to be called to discuss and decide an urgent matter of shorter duration the Managing Trustee and any one of the trustees will form sufficient quorum and they may take necessary decisions on behalf of the governing Body in such emergency meeting.

19.19 The Governing Body shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses to be paid provided that nothing contained shall be deemed to Trustees to spend the income or corpus of the trust for any purpose not authorized by these presents.

19.20 To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.

19.21 To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

19.22 Governing body can operate or open branch anywhere in India and can assign sub governing body state wise.

20. Trust shall be irrevocable.

21. DISSOLUTION

In the event of dissolution of the trust the funds / assets will be transferred only to some other trust / society having similar objectives after adjustment of liabilities.

In the Event of Dissolution of the Trust, the entire Society funds shall be realized and first be used for payment of liabilities of the trust. The assets left if any, shall be disbursed, after obtaining prior approval of the commissioner of Income-tax (Exemption) New Delhi, to other Trust having similar objectives and who have been granted registration u/s 12AA of the Income Tax Act, 1961. In no circumstances it shall be distributed in any manner, to any member of the Trust or their relatives or related concerns.

22. SEAL OF THE TRUST

There will be a general seal in the institution which will be kept in the safe custody of the general secretary / secretary and where the general body is required as per the authority it will be imposed. Whenever the seal of the Trust is to be affixed to any writing deed or document executed by the Trust the same shall be affixed in the presence of persons executing the document. The seal of the Trust shall not be affixed except under the authority of a resolution of the Governing Body.

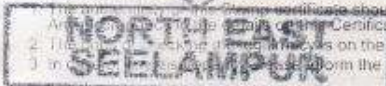

43. All the activities of the Trust shall be non-profitable and shall be done on a "no profit- no loss" basis
44. To work for charitable basis all works concerning Animal Welfare, Animal husbandry, dairy development, Fisheries, Agriculture development and welfare of agriculturist, fishermen and farmers.

All the income, earning, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and object only as set forth in the deed of the trust and no profit, thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profit or in any other manner whatsoever to the present or past or future members of the trust or to any person claiming through any one or more of the present or the past & future members.

No member of the trust shall have any personal claim on any moveable or immovable properties of the trust to make any profit, whatsoever, by virtue of this membership.

All the activities of the Trust shall be charitable basis and any profit arising out of any activity shall be utilized for the purpose of attainment of trust objectives.

AND GENERALLY to do in all public, charitable purposes for public benefit without any discrimination of Caste, Creed, color, gender, religion, faith, Race or any Nationality that in case any of the objects of the Trust are held to be non charitable within the meaning of section 2 (15) of the Indian Trust Act, or any Statutory modification (s) thereof, the Trustee (s) shall not carry out such objectives.



VI. TRUSTEE:

a) Permanent Trustee :

The first trustee as referred in these presents is the "permanent trustee" who shall hold the office of the trust for life unless he voluntarily resign his trusteeship and inform the other trustees in writing.


The next permanent trustee shall be the person so nominated by the Permanent trustee in writing, during his lifetime or by his testamentary disposition, after his death shall be the next Permanent trustee of the Trust and such person shall hold office until his death or resignation. The Permanent trustee so appointed shall have the same powers as provided herein and all the provisions hereof shall apply mutatis mutandis as if the name of such nominee was substituted in place of the name of the Permanent trustee in these presents including power to nominate a person to succeed him as Permanent trustee by testamentary disposition. Nominee must be from Permanent trustee's family.

If there is no any testamentary disposition, then the future permanent trustee of the Trust shall always be male descendant (Preferred) of permanent trustee's family or female descendant of permanent trustee's family. Descendant Preferred over ascendant. It is further clarified that if there are more than one such descendant / ascendant, then, the senior male amongst them may be preferred.

b) Associate Trustee :

Permanent trustee of trust may at any time appoint any person or nominee of any organization as "Associate trustee" for the term of maximum 2 years each. The casual vacancy or vacancy caused by retirement after the expiry of term of two years in the office of Associate Trustee shall be filled by the permanent trustee of the trust. Any associate trustee retiring on expiry of said term of two years may be reappointed by the Permanent trustee for further term of 2 years.

Board of Trustees shall mean and include all trustee & maximum fourteen associate trustees. Board of Trustees shall constitute of not less than 2 (Two) but not more than 14 (Fourteen) trustees.

VIII. DISQUALIFICATION OF THE TRUSTEESHIP

- (i) If he or she has been found to be of unsound mind by a court of competent jurisdiction.
- (ii) If he or she by reason of mental or bodily infirmity has become incapable of acting.
- (iii) If he or she ceases to be a nominee of the organization.
- (iv) If he or she fails to attend three consecutive meetings of the Board of Trustees without just and sufficient cause and without prior intimation to the Permanent trustee of the Board of Trustees;

IX. POWER OF BOARD OF TRUSTEES :

The power of Board of Trustees shall be as follows:

- (i) To appoint, re-appoint, nominate other Trustee.
- (ii) The Board of Trustees may appoint one or more secretaries, supervisors, clerks & other officials, employees, servants & contractual retainers & fix their remuneration.
- (iii) To constitute or re-constitute any committee(s) to discharge any particular function to carry out the objectives of the trust.
- (iv) To draft, re-draft, adopt, amend or alter rules & regulation or by-laws to govern the structure, meetings, functions, powers, duties, authorities of various committee(s) constituted.

X. FUNDS OF THE TRUST:

- (i) The funds of the Trust shall comprise:
 - (a) Donation received from Philanthropists.
 - (b) Endowments in favor of trust.

- (c) Grants from Central and State Government, Corporations and other statutory bodies and Institutions or Individuals from India or abroad.
- (d) Income from properties of the Trust.
- (e) Donations received from general public and Institutions.
- (f) Fees / Funds / Sponsorship amount received against meetings, conferences, training program, rallies, Get together program etc.
- (g) Any other income which may accrue in the working of any other institution controlled by the Trust.
- (h) Donations/Gifts received from individuals, Institutions organization foundations.

(ii) Trustees shall invest the Trust Funds and all moneys in their hands which may require investment in or upon any one or more of the following securities or modes of investment with power from time to time at their discretion to vary any investments and securities held by the Trustees for others of the character hereby authorized, namely,

- a. Any stock or securities issued by or the interests of which shall be guaranteed by the Government of India or any other State in India;
- b. Debenture stock or ordinary stock or shares of any company at a fixed or minimum rate of interest or dividend which is guaranteed by the Government of India or any State Government of India;
- c. In fixed or other deposits with scheduled bank or banks;
- d. in acquiring by purchase or on lease or otherwise any immovable properties of any tenure including the acquisition of leasehold rights in such property and in the case of vacant land the Trustees shall be at liberty to erect building or buildings thereon out of the Trust Funds provided that no vendor purchaser, lessor lessee, sub-lessor sub-lessee or other transferor transferees or any other persons dealing with the Trustees in connection with such immovable properties shall be concerned to see whether the investment is authorized by this sub clause or is in the exercise and/or excess of the Trustees powers and so far as such vendor purchaser, lessor lessee, sub-lessor sub-lessee or other

transferor or transferee or any other person as aforesaid are concerned the Trustees shall have the full right and authority to acquire or give complete title.

XI. (1) POWERS TO FRAME RULES :

- a. For the conduct of their own meetings and business.
- b. For facilitating and carrying out of the objects of the Trust.
- c. To appoint sub-committees, advisory or Governing Bodies for all or any one of its managing institutions and they may delegate their powers to such bodies or others or to some of their members on such terms and conditions as they deem fit.
- d. To employ the necessary staff, take disciplinary actions, to terminate their services, regulate their service conditions etc.
- e. To provide for the meeting, power, decision making, duties, constitution or reconstitution of committees, board of trustees, sub committees etc. and upon being passed by meeting.
- f. Trustees shall not have power to cancel, amend or alter any provisions of this deed of Trust relating to rights, powers and authorities of the Permanent Trustee or of the present or future Permanent trustee. Trustees shall not have power to amend, cancel or alter the type of trustee & number of trustees & also trustees shall not have power to cancel, amend or alter any provisions made in point no. 10 i.e. VOTING PATTERN & point no. 11 i.e. QUORUM.
- g. To decide the salary, pension, provident fund, honorarium, travelling expenses etc. for trustees, subcommittee members, advisory committee members, Governing body members, officers & staff etc.
- h. To decide appropriate Remuneration / honorarium to the trustees for their duties by the author or the Permanent trustee of Trust.

9. (2) THE TRUSTEES MAY AND ARE HEREBY EMPOWERED TO:

- a. Obtain and secure in the name of the Trust any movable/immovable properties by Purchase, Gift, lease or grant and to own and possess the same to sell.

Mortgage, or lease out the same, provided in case of purchase or sale of properties the consent of majority of the trustees has been obtained.

- b. Construct any building, any religious building and orphanage and improve, alter or repair any building which may be acquired in the name of the Trust.
- c. Raise funds and receive donations if necessary for carrying out the progress and objects of the Foundation.
- d. Incur necessary expenses for carrying out the aims and objects of the Trust.

XII. VOTING PATTERN:

Every resolution or question submitted to a meeting shall be decided by a majority of votes of the trustees present at such meeting & voting on the question. The Permanent trustee shall have 2 votes & the Associate trustees shall have one vote each, but in the event of equity of votes, the Permanent trustee of Board of Trustees shall have casting vote whether or not he has previously voted on the question. Any resolution of the Trustees may be rescinded or varied from time to time.

XIII. QUORUM:

There shall be quorum when at least 2 Trustees, (out of which one shall compulsorily be the Permanent trustee), are (at the commencement and throughout the meeting) present. Provided however that with the specific prior consent of the Permanent trustee in writing the quorum for a meeting shall be deemed to have been constituted, even in the absence of the Permanent trustee, but no business at such meeting shall be transacted, other than consented in writing by the Permanent trustee. Provided further that any resolution passed in the meeting of the Trustees, wherein the Permanent trustee was not present may be reconsidered by him and altered in the subsequent meeting/s.

Trustees shall not have power to cancel, amend or alter any provisions made in this quorum.

XIV. ACCOUNTS AND AUDIT :

The Trustees shall maintain true and correct accounts of all receipts and payments and dealings in regard to the trust property and shall also maintain the correct record of their meetings and deliberations. Accounts shall be audited every year by Auditor. The Auditor shall have permanent audit engagement with the trust. The accounting year shall be from 1st April to 31st March of every succeeding year.

XV. BANK ACCOUNT

Bank account of the trust may be opened in any nationalized, scheduled, co-operative or private bank(s) in India or Abroad. The bank account of the trust shall be operated by person authorized unanimously in meeting by writing.

The activities of the Trust will be only within India & if in abroad to be for charitable purpose in India/ for International welfare where India is interested.

XVI. UTILIZATION OF TRUST PROPERTY:

If the income from the Trust property in a particular year is not fully utilized, the unspent income, subject to the applicable provisions of the Income Tax Act, 1961, shall be carried over to the next year or years and spent in such subsequent year or years for achieving the objects of the Trust.

XVII. BENEFITS OF THE TRUST:

The Benefits of the Trust activities in terms of the educational, training and related services it provides shall be available to all Indians, irrespective of caste, creed, race age, sex, or religion except where the benefits are to go to welfare of SC/ST/OBC/NT-DT/Minorities/Women etc.

XVIII. ADDITIONS TO THE CORPUS:

The Trust Fund may be added to, by the income from the initial fund and also by donations and other contributions from time to time.

XIX. INDEMNITY:

The Trustees shall be kept fully indemnified and harmless by the trust against any loss suffered or liability arising against the anything done by them in good faith pursuant to the power and authority conferred on them by this Deed.

XX. DISSOLUTION:

The trust may be dissolved by the board of trustees by passing a resolution with at least 3/4th majorities. On dissolution of the trust, all the properties and other funds of the trust whether with the trustee or anywhere else shall be either utilized in full for the object of the trust or shall be vested in some other trust or any other form of public charitable organization having similar objects.

XXI. AMENDMENT:

The Trustees has power to amend, alter any clause(s) of the trust deed by passing the resolution in their meeting on the basis of majority decision subject to the compliances of prevailing laws of land.

XXII. IRREVOCABILITY:

It is declared that the Trust is irrevocable. If the Trust fails for any reason, in the opinion of the Trustees, the net assets of the Trust, both movable and unmovable shall be handed over to any Trust having the same object, as decided by the permanent trustee appointed by the Board of Trustees.



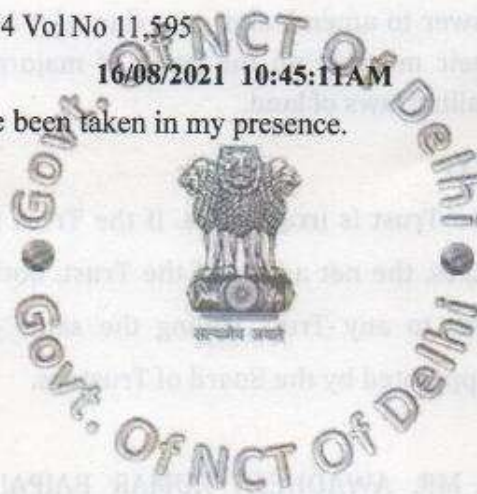
